Specifications for Print-Ready Electronic Advertising Preparation

1. Preferred Mode of File Transmittal

High resolution PDF: The preferred method of material transmittal is via high resolution CD sent to *Nuclear Plant Journal*'s office. Acrobat (Prinergy) PPD and additional specification are available via e-mail.

2. Intimation & Proof

The advertising materials may also be e-mailed to NPJ@goinfo. com and color proof sent to *Nuclear Plant Journal* (via courier mail). PDF file proofs are also acceptable.

Any deviations in the client's submitted file as compared to the specifications given below must be brought to our attention (e-mail: NPJ@goinfo.com) before the material deadline.

3. Preferred File Format

PDF files are preferred as a finished file format. PPD and other Acrobat specifications are available via e-mail. When supplying PDF files, please ensure the following procedures before creating the file.

All art, fonts, graphics, images must be embedded prior to creating the PDF. PDFs **should not contain**:

- Color profiles.
- RGB or LAB color images. All images must be CMYK
- Spot colors unless it is intended to print

All images should be 300 dpi (dots per inch) resolution or higher

DCS 2.0, PDF, Postscript, Tiff/It and Scitex CT/LW

5. Acceptable Native Files (PC or Mac)

QuarkXpress 4.1 or higher Adobe Pagemaker 6.5.2 or higher Adobe InDesign 2.0.2 or higher Adobe Acrobat 5.x or higher Adobe Photoshop 2.5.2 or higher Adobe Illustrator 5.5 or higher Macromedia Freehand 5.5 or higher

*Adobe Illustrator and Macromedia Freehand native art should be saved as an eps.
